Structure, Governance & Management

The Charity (Greener Orkney (SCIO)) is a Scottish Incorporated Charitably Organisation and first registered on 20 March 2019.

The general structure of the organisation consists of **members** and **the board**. Members can appoint people to serve on the board and can take decisions on changes to the organisations' constitution itself. Those individuals serving on the board are called the Trustees. The Register of Trustees is kept by the Secretary to the Charity – Ms Ruth Lea.

Membership is open to any individual living in Orkney over the age of 16.

Recruitment and appointment of the Trustees

Prospective Trustees are required to complete a register of interest proforma and be interviewed by the Chair plus one other Trustee before joining Greener Orkney (SCIO). They will then need to stand for election at the next AGM. Any other Trustee or Member of Greener Orkney (SCIO) can stand for election at the same time. The Annual General Meeting on 6th November 2021 resolved that rule 56 of the constitution be amended so that the minimum number of trustees is five, rather than eight, and that rule 87 was amended to read that no valid decisions can be taken at a board meeting unless a quorum is present, the quorum for board meetings is four charity trustees, present in person or online.

Objectives and Activities

The Charitable objectives of Greener Orkney (SCIO) are twofold. One is the advancement of environmental protection by reducing Orkney's carbon footprint and raising awareness of climate change among the community. The other is the advancement of education by presenting workshops, lectures, and lessons on a range of environmental matters to improve the community's knowledge of climate change and how they can make a difference.

Achievements and Performance 2021/2022

March 2021 to February 2022

From March 2021 to end of February 2022 the Greener Orkney Charity's activities were again severely impacted by Covid-19. However, we managed to have monthly Trustees meetings and to make good progress on some of our projects. In two areas of our activities significant progress was made, first in reducing the amount of food going into landfill through opening the first Community Fridge in Kirkwall. Second, in carrying out more regular beach cleans. We increased the number of people involved in both these activities.

Website

In 2019/20 we received funding from *Tesco Bags of Help* to set up a new website. This will allow us to better communicate with the local community, encourage people to attend events and participate in the activities to help achieve the objectives of Greener Orkney.

We prepared a tender and have had the site developed and reviewed. The development phase was significantly affected by Covid-19 and at the time of writing there are only a few outstanding development items for the supplier to address from our final review. We expect it to go live shortly.

The WEEE Project Scheme

Since 2019, Greener Orkney (SCIO) has been involved with a network of partners in a WEEE (Waste Electrical and Electronic Equipment) recycling / reuse scheme. Greener Orkney's role is to promote to the public the issues concerning waste electrical equipment and how they can help more of this type of material to get recycled, repurposed and re-used. The project ended in October 2021 and exceeded the targets set for Orkney. Employability Orkney-Restart have confirmed that they will continue to collect WEEE items for the foreseeable future.

Beach Cleans & Litter Picks

We now have a significant amount of beach cleaning equipment provided by several sources, including the Marine Conservation Society where we in turn will provide data from some of our ongoing monthly Greener Orkney beach cleans. The aim is to have a beach clean once a month throughout the year, paying attention to bird nesting sites in the spring. We also provide litter picking equipment to other local groups such as Rainbows.

In the current financial year there were beach cleans at Bay of Skaill in December, Houton Pier in January, Newark Bay in Deerness in February, and Warebeth in March.

We supported Bag the Bruck with a beach clean at Houton Head which was very well attended, and we had one around the Peedie Sea and Pickaquoy area in May.

The numbers of people attending the beach cleans have increased allowing us to pick up more litter.

We also link into the Scottish Island Federation. In the last year we provided guidance on recruitment of a new Marine Litter Development Officer for the Scottish Islands and have been a regular contributor to their strategy and plans going forwards.

Community Fridge

In November 2021 the Coop made contact to invite us to apply for a £4000 grant towards the set-up of a community fridge. At the same time Orkney Rape and Sexual Assault Service (ORSAS) approached us to offer a community area as a site for a community fridge. We were successful in obtaining the grant and worked with the Coop and Hubbub, the UK wide association of Community Fridges, to complete all the necessary procedures to set-up the first Community Fridge in Kirkwall. We have been very fortunate in gaining a wonderful group of volunteers who support the collection of the food and running the Community Fridge in Kirkwall.

Events since the end of the Accounting Period

The Community Fridge has proved popular with the residents of Kirkwall and by the end of May we had saved over one tonne of food from going into landfill, with almost a thousand visits to the Community Fridge. We have extended the opening hours to every evening Monday to Friday, and three lunchtimes a week.

We are now working with residents in Stromness to open a Community Fridge in the main street. We have been very fortunate with premises offered to us, which has been fitted out with donations of equipment and a local handyman assisting with the set-up of the interior.

We are also starting to speak to some local schools about how we could work with them to run some community fridges in other parts of Orkney.

Plans for Future Periods – 2022/2023

Our continuing aim is to increase awareness of climate change through education and practical action, such as the Community Fridge and reducing waste. We plan to apply for a grant for a part-time person to help us develop more climate-change related activities in Orkney. We are part of the Community groups in Orkney who are hoping to have a small festival in September to promote climate change activities.

Financial Review

Statement of Financial Position and Financial Review of the Year to 1st March 2022

Greener Orkney (SCIO) holds all assets in the form of cash balances within the current bank account to enable ease of disbursement of funds.

Grants received in the year totalled £3667, with £3000 being received from the Co-op for setting up a Community Fridge and £667 for the WEEE project. In addition £1192 was raised from fundraising activities in The Peedie Cubby and £12 from donations from Amazon's Smile scheme. The three largest items of expenditure were £662 for the purchase of flag-style advertising signs, using the funds from the WEEE project, £313 for litter picking equipment, and the insurance cost of £187 to cover public liability for the Community Fridge and other activities.

On 1st March 2022 the bank account had a balance of £6,624.37 of which £5,612.97 was restricted in use and £1,011.40 was unrestricted.

Statement of Cash Flows

In the year to 1st March 2022, Greener Orkney had income of £4,872.86 and outgoings of £1,604.11. The bank balance increased in the period by £3,268.75

Brief Statement on the Charity's Policy on Reserves

Greener Orkney (SCIO) has no explicit reserves policy. It is to be expected that policies will develop as the charity progresses.

There are no deficits to report.
