## Structure, Governance & Management

The Charity (Greener Orkney (SCIO)) is a Scottish Incorporated Charitably Organisation and first registered on 20 March 2019.

The general structure of the organisation consists of **members** and **the board**. Members can appoint people to serve on the board and can take decisions on changes to the organisations' constitution itself. Those individuals serving on the board are called the Trustees. The Register of Trustees is kept by the Secretary to the Charity – Ms Ruth Lea.

Membership is open to any individual living in Orkney over the age of 16.

# Recruitment and appointment of the Trustees

Prospective Trustees are required to complete a register of interest proforma and be interviewed by the Chair plus one other Trustee before joining Greener Orkney (SCIO). They will then need to stand for election at the next AGM. Any other Trustee or Member of Greener Orkney (SCIO) can stand for election at the same time. The minimum number of trustees is five and the quorum for board meetings is four charity trustees, present in person or online.

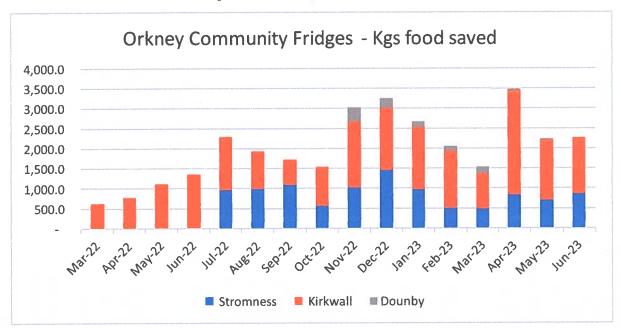
# **Objectives and Activities**

The Charitable objectives of Greener Orkney (SCIO) are twofold. One is the advancement of environmental protection by reducing Orkney's carbon footprint and raising awareness of climate change among the community. The other is the advancement of education by presenting workshops, lectures, and lessons on a range of environmental matters to improve the community's knowledge of climate change and how they can make a difference.

### Achievements and Performance 2022/2023

# Community Fridges

During the period under review Greener Orkney opened and operated three community fridges on the Orkney mainland. The first was in Kirkwall (March 2022), Stromness (July '22) and Dounby (Nov '22). These have been successful in reducing the amount of food going into landfill which is the main purpose of our community fridges. The following graph shows the amount of food by each community fridge which has been saved from landfill. As at the end of June this was the equivalent of 75,000 meals saved.



We continue to run the three community fridges and to train new volunteers who come forwards. We have added Tesco to the list of shops who donate to us, picking up when they have any surplus food. We continue to be supported by all the Co-ops, Fletts, Donaldsons, Argos, Bruces Stores, Wilsons, JW Gray, as well as by other ad-hoc donations.

# Other Projects

We launched our new website, which has been a benefit to the organisation and has helped us recruit new members. The membership number has increased from about 50 at the start of the year to just over 100 members.

The most successful project in the past year (with the financial support from the Community Led Development Fund) has been the slow cooker project, which was run over the winter to counteract the increase in utility bills by reducing the amount of energy needed to cook meals. There was also the option of receiving a specialist cookbook which was taken up by several applicants. Anyone could apply for a slow cooker, though priority was given to families with young children, elderly people, and low-income residents. More than three hundred slow cookers were distributed.

## **Beach Cleans**

We have increased the number of beach cleans undertaken throughout the year and have also started to gather data which goes to the Scottish Islands Federation (SIF) Marine Litter Working Group, of which Greener Orkney is a member. This is also linked to the Marine Conservation Society Beach Watch team, used in campaigning to remove plastic from products.

# **Events since the end of the Accounting Period**

# Bag the Bruck

This year also saw Greener Orkney take on the organisation of Bag the Bruck. In the month of April. In total over 820 bags of bruck were collected and over 1,000 pairs of gloves were distributed in addition to the 19 groups who provided their own gloves. There were also some bags of items for recycling brought back this time which is good news.

11 schools, 6 businesses, 25 community groups and 21 individuals took part in over 63 different events. Thanks to everyone who helped, in particular Cooke Aquaculture Scotland for their generous donation. Also, all the building supply firms in Hatston who provided packets of gloves. Thanks also to the Waste and Recycling team at OIC, the outer island haulers and Scottish Sea Farms, who picked up some extra-large loads.

Finally, thanks to Shona Garson who worked behind the scenes to send out all the packs and gather results.

# Community Fridges

We have a plan to try and expand the range of food and products available in the community fridges to offer plastic free alternatives where appropriate locally. We aim to carry out a small pilot 'Food Hub' project in September 2023, for which we have received a grant of £5,000.

## Nature and purpose of funds

Community Fridge – Funding received in order to establish a community fridge, space where surplus food is shared for free, bringing people together to eat, connect, learn new skills and reduce food waste.

Tesco Groundworks - funding received in order to establishment of a website and to promote green recovery issues through new social media platforms,

WEEE (Waste from Electrical & Electronic Equipment) funding - funding received from XSResources to encourage community engagement, data collation and reporting & marketing support

Slow Cooker Project - Pay and claim grand funding recieved to advertise and distribute slow cookers in order to reduce household carbon footprint and energy use and raise awareness of energy efficient cookery.

Climate Change Festival - Funding received to host a talk about food waste in Orkney and to host an open evening at the Stromness Community Fridge as well as engaging with the community and raising awareness

Foodhub - Funding received to run a 'Food Skills Project'

#### **Financial Review**

# Statement of Financial Position and Financial Review of the Year to 1st March 2023

Greener Orkney (SCIO) holds all assets in the form of cash balances within the current bank account to enable ease of disbursement of funds.

Six grants were received in the year totalling £11,957, and a further £2,645 was received after the end of the year relating to the third tranche of costs for the Slow Cooker project. The largest items of expenditure related to the Slow Cooker project where we spent just over £8,000 out of a possible £10,000 grant. The project costs were less than budgeted because Tesco was able to source slow cookers for us at a greatly reduced cost.

On 1st March 2023 the bank account held a balance of £6,222 of which £3,951 was restricted and £2,271 was unrestricted.

#### **Statement of Cash Flows**

In the year to 1st March 2023, Greener Orkney received total receipts of £13,863 and made total payments of £14,264 resulting in the bank balance decreased in the period by £402.

Unrestricted receipts during the year amounted to £1,906 and payments amounted to £646 resulting in a surplus of £1,260.

Restricted funds relate to five projects, four of which have available funds amounting to a total of £6,528. The Slow Cooker project restricted funds were in deficit at 1st March 2023, pending receipt of the final tranche of funding in the amount of £2,645 for which a claim was submitted on 6th March 2023 and funds received on 22nd March 2023.

# Brief Statement on the Charity's Policy on Reserves

Greener Orkney (SCIO) has no explicit reserves policy. It is to be expected that policies will develop as the charity progresses.
